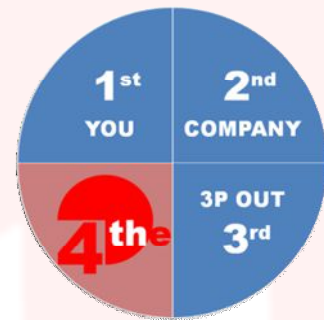

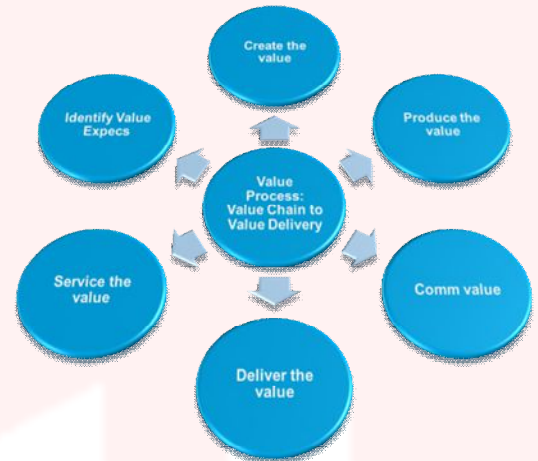


4th How to make it all feasible?

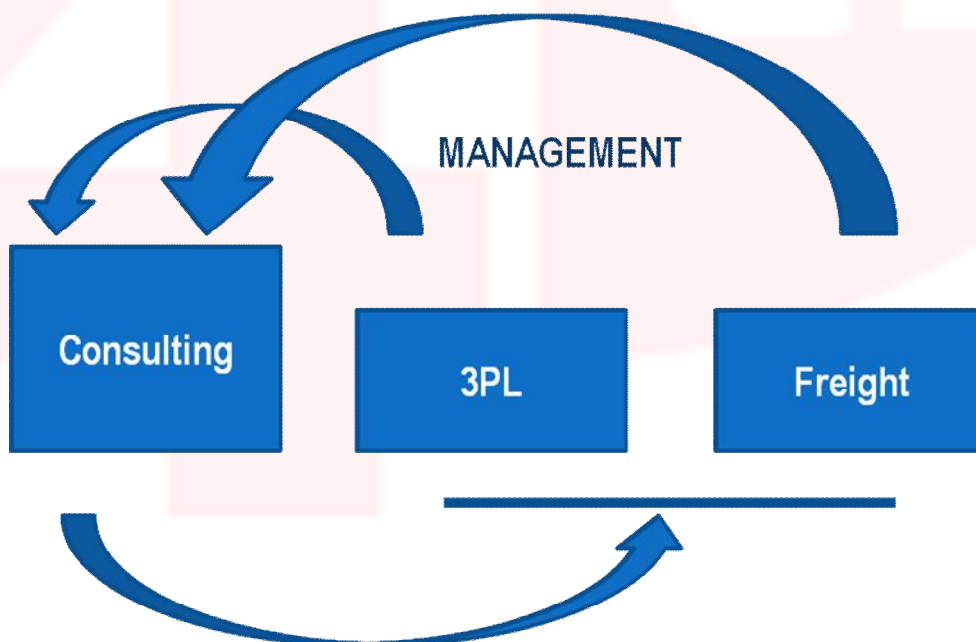

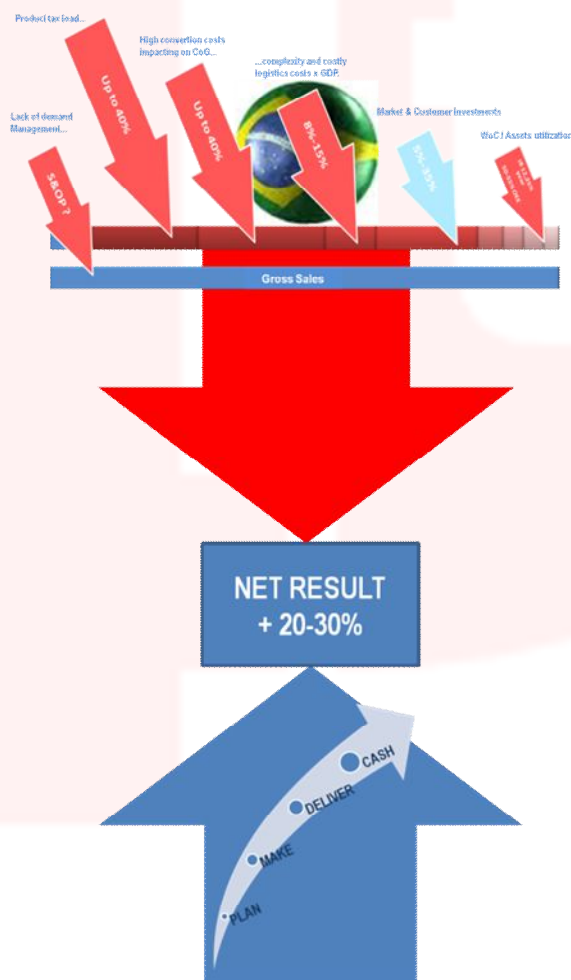
